

Carbon for Farmers Voucher Program (CF-VP) – Round 1

The Carbon for Farmers Voucher Program (CF-VP) supports farmers by assisting with the cost of accessing professional carbon farming advice. The CF-VP increases landholders' understanding of the feasibility, and integration of carbon farming into production systems.

Undertaking a carbon farming project represents long-term commitment, so accessing independent, property-specific advice is essential to the success of a project. The CF-VP helps farmers to understand their sequestration potential, the requirements, and potential returns of undertaking a project.

In a Pilot for the CF-VP, 7 applicants were offered a \$10,000 voucher to develop a Land Management Strategy; a requirement of registering a carbon farming project with the Clean Energy Regulator. In Round 1 of the CF-VP, applicants could receive up to \$10,000 (ex-GST) with a minimum 10% cash co-contribution to develop a Land Management Strategy with a service provider of their choice.

A total of 66 applicants across the South-West Land Division (Agricultural Zone) were offered a voucher in Round 1 of the Carbon for Farmers Voucher Program.
